SCRAP METAL DEALER - SITE LICENCE

Please find enclosed your site licence, which is issued in accordance with the above legislation and a list of the requirements which must be complied with whilst operating your business.

You **must** ensure that a copy of this licence is displayed in a prominent place in an area which is accessible by the public at each site listed in the licence. You are also required to notify the council of changes to the licence, such as name changes to individuals or the company name. However, this cannot be used to transfer the licence to a different person as this would require a new application to be submitted in the name of the relevant person. If you cease trading as a scrap metal dealer you are also required to inform the council within 28 days. Please note that failure to do any of the above contravenes the legislation and may lead to prosecution in the Magistrates' Court.

Please note that the licence is valid for 3 years and it is **your responsibility** to apply for a new licence prior to this licence expiring. We recommend that a new application should be submitted at least 2 months prior to the expiry date of this licence.
